We will discuss SB 770, which directs the California Department of Health & Human Services to begin discussions with the Federal Government to see if the state can have federal funds from Medicare and Medicaid (Medi-Cal) redirected into a state fund to finance single payer healthcare in the future. We will also summarize new legislation including SB 616 Paid Sick Leave, Cannabis Legislation SB 700 and AB 2188, SB 699 Non-Compete Agreements, SB 553 Workplace Violence, SB 497 Rebuttable Presumption of Retaliation, AB 594 Public Prosecution for Labor Code Violations, AB 1228 Fast Food Minimum Wage, SB 525 Health Care Industry Minimum Wage, SB 723 Rehire/Retention of Displaced Employees in Hospitality and Service Industries, and SB 848, Reproductive Loss Leave.
