Learned Cybersecurity Governance Themes



Tone at the Top

- Cybersecurity requires leadership, oversight, commitment, and behavior adoption

It's a process

- Continual improvement – not “set it and forget it”

False sense of “security” is pervasive

- Not at all prudent to assume that “IT has it all taken care of”
- *IT* skills and objectives can CONFLICT with *Information Security* skills and objectives
- Many IT staff are not versed on deployment and support of IT Security frameworks

Best to start anytime, rather than wait

(better to know your vulnerabilities than to wait for a breach)

- Lightning can, and does, strike again

What triggers corporate leaders to undertake cybersecurity work?

- Regulatory, fear, proactivity, fiduciary responsibility
- A threat actor or internal actor causing a breach or a hack
